<sup>1</sup> CCA Students: Financial aid disbursements may vary due to additional processing requirements for CCA students. Students are responsible for paying community college tuition. Disbursements are based on the start date of student's first course, regardless of school.

<sup>2</sup> Scholarships disburse during week 3 of the term at earliest and at least 11 days after the start of the student's earliest class.

<sup>3</sup> "Begin wk #" indicates the earliest week of the term a source of aid will disburse; the source of aid will not disburse until at least "# days after the start" of the student's earliest class for the term

<sup>4</sup> Ohio College Opportunity Grant (OCOG) will disburse, at earliest, during week 8 of the term. The timing is dependent on the State of Ohio budget being finalized.

Notice 1: Federal Direct loans have 2 disbursements per term based on the start date of your first class for the term. Prior to the calendar mid-point of the term, the loan amount accepted will be split in half, and each half will have a separate disbursement date. After the calendar mid-point of the term, the loan disbursements will occur on the same date for the full amount accepted.

Notice 2: Disbursement refers to the posting of aid to the student account to apply to tuition and fees. If there is a credit balance on the student's account after the disbursement of aid, a refund will be sent out to the student through preference set up in BankMobile. Any change in enrollment can adjust and/or delay aid disbursement and refund amounts.

Notice 3: The balance/credit shown in the Account Summary and Account Activity views in Self-Service reflects an anticipation of aid and may not reflect a realtime balance or credit on your account. If you expand the Financial Aid section you can identify if aid has disbursed or is still anticipated. If you click on Payment Options to go to the Transact site you can verify your realtime balance.
