³ Ohio College Opportunity Grant (OCOG) disburses at earliest during week 7 of the term due to the start of the State of Ohio's fiscal year.

⁴ Exception to "Begin wk 3": Ohio National Guard Scholarship and other State of Ohio scholarships disburse at earliest week 5; and will not disburse until at least "# days after the start" of the student's earliest class for the term. Delay in disbursement is possible due to the start of the State of Ohio's fiscal year.

Notice 1: Federal Direct loans have 2 disbursements per term based on the start date of your first class for the term. Prior to the calendar mid-point of the term, the loan amount accepted will be split in half, and each half will have a separate disbursement date. After the calendar mid-point of the term, there will be only one loan disbursement for the full amount.

Notice 2: Disbursement refers to the posting of aid to the student account to take care of any tuition and fees. If there is a credit balance on the student's account after the disbursement of aid, a refund will be sent out to the student through Bank Mobile the following week. Any change in enrollment can adjust and/or delay aid disbursement and refund amounts.
