Any change in enrollment can adjust and/or delay aid disbursement and refund amounts.

Notice 3: The balance/credit shown in the Account Summary and Account Activity views in Self-Service reflect an anticipation of aid and may not reflect a current balance or credit on your acount. If you expand the Financial Aid section you can identify which aid has disbursed or is still anticipated. If you click on Payment Options to go to the ePayments site you can verify your current balance.
