

Master of Education in Educational Leadership, Principal Licensure Focus Area Professional Licensure Information

Professional Licensure Programs

A professional license is typically regulated by state laws and is required for graduates of these programs to practice, to use the professional designation in their title, and/or to gain employment in certain occupations.

The Master of Education in Educational Leadership program, Principal Licensure focus area is designed to prepare students for a career as a licensed principal in Ohio in the grade bands PK-6, 4-9, or 5-12.

State Licensure

Requirements for teacher licensure vary by state and may involve more than successful degree completion. Graduates who apply for a license may need to satisfy other requirements, such as passing an examination, completing an application, and submitting to a background check. Some states have different processes and requirements for applicants who have completed their academic program in a different state.

Educational requirements for principal licensure can include specifications for the applicant's type of academic degree, type of educational institution where the academic program was completed, and curriculum content within the academic program. Some states offer multiple pathways to principal licensure, including recognizing a license earned in another state or providing options for qualified professionals who wish to transition into the education field. *The lists below pertain <u>only</u> to the educational requirements to obtain an initial state principal license*. Alternative pathways to licensure and additional requirements, other than educational, are not considered in these lists.
