OhioLINK agreements offer limited open access publishing

OhioLINK has announced new agreements with Elsevier and Springer, as well as an expanded renewal for their Wiley Open Access publishing agreement that offers authors from Franklin University limited APC-free open access publishing benefits. Franklin University affiliated authors also have OhioLINK open access publishing benefits available through IOP and Cambridge University Press. Eligibility is determined by the affiliation of the corresponding author (the primary contact throughout the publishing process), the timing of submission and acceptance for publication, and subject to availability of APCs. Upcoming Theory Courses

There's still time for doctoral students to register for our research core elective courses, including MTHD 817, "Social and Critical Theory." MTHD 817 will introduce students to the chief theoretical schools that inform research in the social sciences: "postmodernist" theories, queer theory, gender theory, critical race theory, disability theory, and structuralist theory among others. Students will consider how social and critical theory has been deployed in the social sciences over time as well as how this same body of work influences contemporary public and political discourse. Throughout the course, students will consider how social and critical theory can be applied to their own research.
