

I was **NOT a U.S. Citizen** between the ages of 18 through 25 AND I entered the US for the first time **AFTER** the age of 26 and therefore, was not required to register. You must provide documentation to support your claim. Submit the following information:

1. This form completed and signed; AND
2. Valid documentation from one of below lists:

Non-citizen:

- entry stamp in your passport, or;
- I-94 with entry stamp on it, or;
- Letter from the U.S. Citizenship and Immigration Service (USCIS) indicating the date you entered the US, or;
- If you entered the United States illegally after your 26th birthday, you must provide proof that you were not living in the United States from age 18 to age 26. Please note: your Resident Alien Card (Green Card) is not valid as proof of entry to the United States.

Non-Immigrant Status:

- F1 Student Visa - if you entered the United States as an F-1 Student, and remained in that status until your 26th birthday, you would need to provide documentation indicating that you were admitted on an F-1 visa and attended school full-time as required. (Acceptable documents for this situation include copies of your I-20 or a letter from the school you attended indicating your full time attendance as a non-immigrant alien), or;
- Other non-immigrant statuses. You must submit documentation of your status when you entered the U.S. You must explain, if at any point, you violated the terms of your visa, or overstayed your visa and became an undocumented alien

I was **Not a U.S. Citizen** between the ages of 18 through 25 AND I entered the US for the first time **BEFORE** the age of 26 and did not register. Submit the following information:

1. This form completed and signed; AND
2. A copy of the **Selective Service Status Information Letter (SIL) is required.** Visit <https://www.sss.gov/Registration/Status-Information-Letter> for additional information about this letter or call (847)688-6888, **AND;**
3. A **personal statement** is required explaining why you failed to register with Selective Service upon reaching age 18 and before reaching age 26.
